We believe:

- Religious Education and prayer invites us to meet, experience and develop a relationship with our loving God in the journey of life.
- Religious Education and prayer urges us to reflect upon and celebrate our beliefs within a Spirit-filled Community.
- Religious Education and prayer invites us to discover the many rich symbols of our Church and to participate in meaningful liturgical experiences.

Therefore, we aim to:

- Model a variety of methods for individual and communal prayer.
- Enable children to experience a variety of prayer forms with self, others and through song, movement, dance, listening, scripture, silence, reflection, meditation music, and recorded work.
- Assist the children in recognizing the importance of prayer in their daily lives and provide them with the opportunity to respond in prayer to events in their lives.
- Introduce age appropriate formal prayers and explore their origin and meaning.
- Create opportunities to engage in a range of faith sharing experiences and celebrations within community through:
 - assemblies
 - Whole school or individual class Masses and Prayer celebrations
 - Other Sacramental celebrations, Yrs 3 – 4 as part of a Parish Sacramental program.
 - Other celebrations of faith within the faith community
- Develop the children's awareness of the relationship liturgy has with our own daily living.
- Assist children in their understanding of the different features and parts of liturgical celebrations so they can more fully participate in them.
- Foster in children an enjoyment and love of liturgy.

Organisation

- Each classroom teacher will be responsible for organising daily prayer and for maintaining a prayer focus/table which reflect the liturgical seasons. Some daily prayer will include Christian Meditation.
- Both traditional and spontaneous prayer should be included in daily prayers.
- All RE units taught should include an element of prayer.
- The school prays together at Friday assembly.
- We gather as a school to pray in celebration, times of crisis or when serious incidents have occurred.
- Prayers are included regularly in the school newsletter especially in relation to special events, celebrations, commemorations, crisis or incidents.

Background: We work in accordance with the “Steps In Faith” Policy on Sacraments of Initiation, released by the Diocese of Sandhurst. St Patrick’s Parish and School conducts preparation programs for Reconciliation, Confirmation and First Eucharist in conjunction with Our Lady’s Parish and school and St Bernard’s School.

We believe:

- The role of parents is vitally important in the children’s sacramental preparation and therefore the emphasis and time commitment to the preparation needs to be directed towards them.
- That parents, as with Baptism preparation, will approach the Parish to enrol their children in sacramental preparation.
- That deepening our understanding of the sacraments is a life-long process which is primarily lived out in the context of family and Parish.

Therefore, our aims are:

- To initiate children into the liturgical life of the faith community by:
 - creatively using authentic and robust symbols and rites,
 - by inviting, welcoming, accepting and affirming families yet opening them to new challenges,
 - making a commitment to support families in the process,
 - simultaneously delivering a Prep – 6 program in the school to support the family Parish program.
- To provide catechesis that is appropriate to the age and ability of the children so that they develop:
 - a sense of wonder and awe of God through family and Parish celebrations,
 - an appreciation that God loves and forgives them,
 - an ability to distinguish between ordinary food and Eucharistic food,
 - familiarity with prayer and liturgy through regular experiences in the Parish, the home and the classroom.

Religious Education units are to be taught, at all levels of the school, to support the particular sacramental program conducted by the parish.

Information for Implementation of Religious Education

The specific areas of Scripture, Prayer, Liturgy, Sacraments, and Social Justice are taken into consideration simultaneously in the planning and delivery of Religious Education, so that the program is both comprehensive and holistic.

Issues of Social Justice are being addressed by aligning the Social Skills and Self Esteem Programs (in accordance with Personal and Interpersonal Learning strands of (AusVELs) to the Gospel Values and by placing Religious Education within the Integrated Curriculum when the focus is appropriate.

Agreed Major Teaching and Learning Strategies

The Shared Christian Praxis is our major strategy. The delivery of our Religious Education program incorporates teaching and learning strategies that are common to all Domains. (Refer to Sandhurst Teaching and Learning Module, St. Patrick’s Teaching and Learning Policy and The Source Of Life).

All Religious Education units will be based on our Diocesan Program – *Source Of Life*.

- Drama, dance and music
- Life Relationships Program
- Godly play

Organisation

- One Pupil Free Day (or equivalent) per year for whole staff Faith Development. These may involve other CREW schools.
- Religious Education curriculum will be planned, delivered and assessed (of knowledge only where appropriate) as in all other areas of the curriculum.
- That a daily allocation of time be given to Religious Education and where possible, integrated as part of the overall curriculum.
- That scripture, prayer and liturgy be included in the planning of all units as recommended in the Source of Life.
- That staff prayer be well planned and shared by all staff.
- Religious education Co-coordinator will brief staff on issues and developments in RE.
- All teachers are to be accredited to teach Religious Education. Opportunities to gain accreditation will be provided and support for ongoing professional development will be given.
- Teachers have the responsibility of organising the Religious Education program for their own class. It is expected that Religious Education is timetabled in each classroom.
- Daily prayer will be organised by the classroom teacher and Religious Education units should be integrated where possible.

Planning

Yearly overviews planned at annual whole staff planning day

- Term plans developed at Unit level meetings
- Individual weekly plans aligned to the term planner
- Sacramental Program Prep – 6
- Reconciliation
- Eucharist / Confirmation
- Parent meetings to coincide with whole school sacramental program
- Liturgical meeting to coincide with Celebration of Sacraments

Links with Families and the Parish Community

Links with families and the parish community are an integral part of St Patrick's Primary School. Monitoring Implementation Program & Policy Development

Role Descriptions

Principal:

The principal has overall responsibility for the implementation and effectiveness of the Religious Education program in the school.

Parish Priest:

The Parish Priest exercises a pastoral care role of the parish community. He has the overall responsibility of the faith development in the school and parish community. He also develops and nurtures school/parish/community relations. The parish Priest celebrates liturgies, rituals and special events and works with the sacramental team in overseeing the implementation of the sacramental program.

Sacramental Team:

The CREW team work together in preparing, implementing and evaluating the Parish Sacramental Program. They assist the Parish Priest in providing opportunities for both child and adult faith development.

Religious Education Co-ordinator Role Description

Active involvement in personal expression of faith:

- Actively lead or participate in prayer and hymns at assembly, class and school gatherings.
- Assist with the preparation of RE gatherings.

Promote a climate which is faith centred:

- Be models at assembly and prayer.
- Align school and parish focus at special times eg Project Compassion

Contribute to practices that facilitate the Catholic Christian message:

- Adult faith development reading and sharing at staff meeting.

Religious Education – Support for Staff
